Understanding these conditions, the Artist hereby agrees to release the Gallery from any liability for vandalism, fire, theft, flood, damage to building, misplacement, loss, or any other cause during the time the Artwork is in its possession.
- 15. HANGING: Artists hang their own show, with final approval (of placement, etc.) by the Art Exhibit Committee. A layout plan must be approved by the Art Exhibit Committee at least two weeks prior to installation.
